## GENERAL INFORMATION

### FACTS & FIGURES

**Location:** The Village of Lakewood is located in McHenry County, which is currently one of the fastest-growing counties in the State of Illinois. The Village shares boundaries with Crystal Lake, Lake in the Hills, Huntley, and Woodstock.

**Population:** As of the 2020 census, the Village had 4,283 residents. There are over 1500 homes in the community.

**Area:** The Village's land area is just over 5 square miles.

**Open Space:** The Village has a total of about 650 acres of open space, which equals about 3/4 of an acre per household. There are 6 lakes, including Crystal Lake which is situated partially in the Village of Lakewood and partially in the City of Crystal Lake; 4 golf courses; several natural areas or wetlands, including the Kishwaukee Fen Nature Preserve; a number of public and private parks and beaches; a bike/walking path, with more planned; and permanent open spaces in the newer subdivisions.

### HISTORY

An informative history of the Village and its homes was written on the occasion of our 65th Anniversary celebration in 1998. A copy of The Homes and History of the Village of Lakewood is available to residents and non-residents.

### SHOPPING AND TRANSPORTATION

#### SHOPPING:

Lakewood Commons located at the intersection of Ackman Road and Redtail Drive offers a variety of neighborhood convenience shops and Lou Malnati's Restaurant for the residents of Village of Lakewood. Other retail districts available to residents are along Route 14 and in downtown Crystal Lake, as well as along the Randall Road corridor in Lake in the Hills and Algonquin.

#### TRANSPORTATION:

Lakewood is easily accessible off of Interstate 90 via the full Randall Road interchange or Rt 47 Interchange, both to the south. Commuter trains to Chicago are available in downtown Crystal Lake. O'Hare International Airport is 45 minutes away via I-90, and a general aviation airport is located in Lake in the Hills.

### SCHOOLS

#### PUBLIC SCHOOLS:

Most of the Village of Lakewood is within the boundaries of Crystal Lake Elementary School District 47 and Crystal Lake High School District 155. Although subject to periodic redistricting, Lakewood students residing west of Huntley Road currently attend West Elementary School, while those east of Huntley Road attend South Elementary. All of these students currently attend Richard F. Bernotas Middle School and Central High School.

The Turnberry Meadows Subdivision lies within the boundaries of Huntley School District 158 and students living there attend Huntley Elementary, Middle and High schools. Hidden Lakes Subdivision lies within the boundaries of Huntley School District 158 and Crystal Lake School District 47 & 155. Call the districts for up-to-date information:

The college offers 2-year associate degrees as well as extensive continuing and community-educational programs, and four-year degree completion programs through cooperating institutions. The college mails a catalog of its courses and community education programs to all residents.

**OTHER SCHOOLS:**

A number of parochial schools, nursery schools and day-care facilities are located in the area. Several satellite locations of other universities offer classes in nearby suburbs.

The Village of Lakewood is not part of a library district, however, residents have the following choices for fine library services.

A college library card is available free of charge to all residents who show proof of residency.

The college has a lending library and reference section.

The State of Illinois has instituted a law which requires that residents who desire to join a library, and who are not part of a library district, only join the library which is in the same high school district in which they reside. Therefore, Lakewood residents in the Turnberry Meadows subdivision and Hidden Lakes Subdivision who wish to join a library must contact the Huntley Area Public Library or the Crystal Lake Public Library to determine which library district they belong to. All other Village residents must apply to the Crystal Lake Public Library. Library cards from each library are good for all service at any library in the state. Contact the post office for counter hours. Their lobby is open 24 hours a day for access to post office boxes, postage scale, and stamp machines.

The Village shares the zip code of 60014 with most of the City of Crystal Lake, and mail to resident's homes may be addressed either as Village of Lakewood, IL or Crystal Lake, IL. The postal service has recommended not using simply Lakewood, IL because there is a Lakewood post office in downstate Illinois where mail may otherwise be misdirected.

## EMERGENCY INFORMATION

**Emergencies:** The Village is covered by an enhanced 911 system.

**Dial 9-1-1 for any emergency.** For non-emergency police calls or for other police-related questions, call 815/459-2151. For non-emergency fire calls, call 815/356-3640.  
To arrange a vacation house watch, please visit our website to enroll.

**Poison Control:** 800/942-5969

**Fire and Ambulance:** The Village has an agreement with the City of Crystal Lake for fire and ambulance service. **Dial 9-1-1 to have a fire truck or ambulance dispatched.**

**Tornado Siren:** A 3-minute continuous tone siren is sounded to alert residents of a tornado warning. When you hear the siren, **do not call 9-1-1**; just take immediate shelter. No "all clear" signal is given. Residents should listen to local radio (FM 105.5) and TV news stations for updated weather information. Note that all sirens in the Crystal Lake area, including the Village's siren, are tested at 10:00 a.m. on the 1<sup>st</sup> Tuesday of each month.

## GOVERNMENT

The Village of Lakewood is an independent municipality under the statutes of the State of Illinois. Most of the Village lies in Grafton Township. The area east of Meridian Street is in Algonquin Township, and a portion of the Brighton Oaks subdivision and the area near Route 47 and Route 176 intersections is in Dorr Township.

The Village operates under the President-Trustee form of government. The Village Board is comprised of a President (or mayor) and six Trustees who are elected on a non-partisan, at-large basis for staggered four-year terms. The Village Clerk, Treasurer, Attorney, Administrator, and Police Chief are appointed by the Board. The Village Board is the community's policy-making body and has created a variety of advisory boards and commissions on which citizens can volunteer to participate. The day-to-day operations of the Village are administered by full-time professional staff.

Agendas are posted at Village Hall and Redtail Golf Club the weekend prior to each Village Board meeting. Residents are welcome to attend Board meetings which are held on the second and fourth Tuesdays of each month at 7:00 p.m. at Crosspoint Church, 8505 Redtail Drive.

The Village operates with full-time Administration, Police, Public Works, Finance and Building Departments. All but Public Works are located at Village Hall. Day-to-day operations of the Village are managed by a full-time professional Village Manager. Other functions are provided by contract, inspections and engineering. The Village also owns and operates RedTail Golf Club.

### **BUILDING DEPARTMENT:**

The Building Department is responsible for all building issues in the Village. The Building Department is located in the Village Hall and can be reached by calling 815/459-3025. Building Department hours are from 8:30 a.m. to 4:30 p.m. Monday through Friday.

Fire Protection Services and Emergency Lifesaving and Rescue Services in the Village of Lakewood are provided by the Crystal Lake Fire Rescue Department. The Village enjoys a low crime rate, largely due to the pro-active community policing philosophy and policies of the Villages own 24-hour Police Department. The Department is headed by a full-time Police Chief. Phone calls are handled by the McHenry County Sheriff's Department. During the summer months, the department also operates the boat patrol on Crystal Lake.

**House Watch:** If you will be away on vacation and your home will be empty, sign up for our home watch service. Visit the Village's website and click the blue house for forms. Or call the non-emergency police number, 815/459-2151, to arrange.

**Text Caster:** Stay update to date with real time road closures, accidents, and Village bulletins through Text Caster software. Visit the website to sign up.

**PUBLIC WORKS DEPARTMENT:**

This department is responsible for maintaining the streets, equipment and public property, snow plowing, water and sewer system, hydrant flushing, brush pickup, and similar services.

**HYDRANT FLUSHING**

Hydrant flushing is a regular part of the maintenance program. Flushing dates will be announced in the Village communication platforms. Only authorized persons may open or close a fire hydrant. Residents should make every effort to clear away snow and keep hydrants visible during the winter season.

**SANITARY SEWERS**

Each resident is responsible for the maintenance and repair of sewer service lines within his/her home and out to the point of connection with the municipal sewer system. Unlawful connections (i.e., sump pumps, gutter drains, etc.) are not allowed.

**SNOW REMOVAL**

The Village plows all dedicated streets. Rocks or other obstructions must be moved at least 10 feet back from the paved surface after November 15 to prevent damage to the plows and/or injury to workers or passers-by from flying debris.

**TREE REMOVAL PERMITS**

No vigorous and healthy tree taller than 20 feet or larger than six (6) inches in diameter as measured twelve (12) inches above the ground shall be removed without a tree removal permit. It is the stated public policy of the Village to maintain, to the greatest extent possible, existing trees within the Village. The purpose of Section 21.20 is to preserve existing natural streetscapes throughout the community.

Permits are available free of charge. Permit requests may be obtained by visiting the Village's website or in-person at Village Hall.

Any tree removed prior to or without approval shall be punishable by a fine of not less than \$500 nor more than \$1,000 per tree removed.

**SERVICES**

Village Hall hours are 8:30 a.m. to 4:30 p.m. Monday through Friday. There is an answering machine which takes messages during off hours, and a locked drop-box at the exit of the parking lot where payments and correspondence can be left when the office is closed. Services offered at Village Hall include issuance of tree removal permits, garage sale permits, building permits,

temporary handicapped parking permits, and notary public. The Village Administration Department, Police Department, Finance Department, and Building Department are headquartered at Village Hall.

**BOAT, TRAILER, RV STORAGE DURING THE OFF SEASON:**

November 1 through March 31, boats, trailers and RVs must be stored indoors or if outdoors, in areas where permitted, then only in the rear yard on a pad. **(They can never be stored outdoors in the Turnberry subdivisions, Brighton Oaks, Hidden Lakes and The Reserve.)**

**BRUSH PICK-UP:**

The Village sponsors a brush pickup each spring and fall. Dates are announced in the Village communication platforms. On publicized dates, unbundled brush up to 3 inches in diameter and no more than 6 feet in length may be left adjacent to the street for collection. It is up to the homeowner to dispose of brush the rest of the year.

Wood chips are periodically made available to residents on a first-come, first-served basis at the following locations:

6650 Haligus Road - South of our Sewer Treatment Plant (Note: There is limited access to this location during wet conditions)

Bring your own container and call 815/459-3025 to arrange a time for collection. Further information on weekly brush pick-up, offered by our waste hauler between April and the 1<sup>st</sup> Friday in December, is available elsewhere in this brochure.

**UTILITIES AND UTILITY BILLING:**

The Village operates a full-service public utilities operation with water and sewer plant facilities. The Village offers a utility billing automatic payment program (ACH debit). The form can be found on the last page of this packet. Payment by Visa, Mastercard, Discover or American Express for utility payments can be done at Village Hall or via the website through the state E-Pay service. There is an additional fee for this service. To receive bills via email, please contact Village Hall.

The Village bills residents every two months for utilities and refuse collection. The east side of the Village, which has private wells, is billed for sewer and refuse, and the rest of the Village is billed for Lakewood Utilities (water and sewer) as well as refuse. Bills are for the preceding 2-month period and are due 20 days from the billing date. Late payments are subject to a 10% penalty if received after the due date shown on each bill. In order to avoid late charges, we recommend that you mark your calendars for the 15th of each month in which you should receive your bill (as shown below), and call Village Hall if you do not receive your bill by then so that we can mail you a duplicate. Call Village Hall any time you have a question about your bill. **Please note that no credits can be given to snowbirds.**

## PERMITS, LICENSES, STICKERS, AND CODES

### ARCHITECTURAL REVIEW

Prior to the commencement of any new home or any exterior or structural construction activity, a homeowner must submit plans for an architectural and landscaping review process before a building permit can be issued. Details are available at Village Hall.

### BIKING, SKATEBOARDING AND ROLLERBLADING

Bikers, skateboarders and rollerbladers must go with the flow of traffic, be aware of the vehicles around them, and move to the side of the road to allow vehicles to pass.

### BUILDING PERMITS AND CODE ENFORCEMENT

Building permits are required prior to construction or alterations. Please visit our website or contact the Building Department for fees and details on all work from re-roofing, decks, patios, driveways and additions, to new construction.

The Villages building codes cover structural, electrical, plumbing, fire prevention, and HVAC issues. General contractors as well as contractors for single or small-scale projects must have a \$10,000 surety bond posted in the Village. In addition, Village codes govern zoning, property maintenance, and landscaping (including tree preservation).

### CURFEW

For those under 17 years of age, cannot be on any public road, alley or park:

Sunday - Thursday: 11:00 p.m. to 6:00 a.m. the following morning

Saturday, Sunday, and day preceding a holiday: 12:01 a.m. to 6:00 a.m.

### DOG LICENSES

Per McHenry County Code, Article #XVII-Sec. 3, McHenry County requires dog owners to register and obtain valid licenses for all dogs within 30 days of obtaining a rabies vaccination. A current rabies vaccination certificate must be presented when applying for the tag. Discounts are given to senior citizens as well as for dogs that have been spayed or neutered. Replacements for lost tags are available for a nominal fee. **Tags can be purchased at the McHenry County Health Animal Control Department located at 100 N. Virginia Avenue, Crystal Lake** (call 815/459-6222 for hours).

### DOG RUNS

Dog runs require a building permit in the Village.

### VEHICLE STICKERS

The cost of the Vehicle Sticker is \$10 per vehicle registered at your home. The sticker will be valid each year from May 1st through April 30<sup>th</sup> of the next year. The same payment options are available as Utility Billing; i.e. mail, drop box at Village Hall, in person, or use of E Payment.

### GARAGE SALE PERMITS

Residents are permitted up to three garage sales within a 12-month period. Garage sales can be held for up to 3-days at a time between the hours of 9 a.m. and 5 p.m. Permits are required and are free of charge. Stop in at Village Hall any time prior to your sale to fill out the application and obtain your permit and a copy of the Ordinance governing garage sales. The permit is free of charge. Note that vehicles, boats, etc. that are displayed for sale can only be parked in a resident's

driveway. Any other items for sale are considered a garage sale and require a permit to be displayed outside.

### **HANDICAPPED PARKING PERMITS**

Temporary permits (valid for up to 3 months) can be obtained at Village Hall free of charge when residents provide authorization from their physician. Permanent permits can only be obtained at state facilities.

### **J.U.L.I.E.**

Call J.U.L.I.E. (Joint Utility Locating Information for Excavators) at 800/892-0123 for utility line locations on your property before doing any digging! This includes even landscaping work. The service is free of charge.

### **LEAF BURNING**

Open burning of leaves and debris is prohibited in the Village.

### **LEASH LAW**

The Village has a leash law which requires that dogs be leashed when not on the owner's property. Additionally, anyone walking a dog must clean up after the dog if it deposits waste on public or private property. We encourage all residents to be considerate of their neighbors with the above issues, as well as not leaving dogs outside if they bark.

### **NOISE**

Radios, television sets, musical instruments and the like are considered a nuisance if heard beyond a property line between the hours of 10:00 p.m. and 7:00 a.m. the following day. Loudspeakers and public address systems and the like are considered a nuisance if heard beyond a property line between the hours of 11:00 p.m. and 7:00 a.m. the following day. Domestic power tools (snowblowers are exempted if required for snow removal) cannot be used outside the home before 7:00 a.m. or after 8:00 p.m. Monday through Saturday, nor before 9:00 a.m. or after 8:00 p.m. on Sundays and holidays.

### **PARKING**

No parking is permitted on Village streets where signs are posted to that effect.

### **SOLICITORS AND PEDDLERS**

All solicitors are required to register with the Village. Upon registration, they are provided with a permit showing the date(s) they are allowed to solicit. Solicitors must respect any resident's home that displays a no solicitor sign. If you have any questions about someone who comes to your door or is in your neighborhood, call the non-emergency number for the Police Department at 815/459-2151.

### **TREE PRESERVATION PROGRAM**

The Village has an ongoing tree program to care for all parkway trees. Any tree or shrub which interferes with traffic should be trimmed by the owner of the abutting property. Homeowners are responsible for removing dead or dangerous trees on their property. Note that a permit is required (free of charge) prior to removing any trees, including dead or diseased ones, that are more than 20 feet tall or at least 6 inches in diameter at a height of 12 inches above the ground. The conditions under which a tree removal permit may be issued are listed in the Village's Landscaping Code. **Tree removal permits are required prior to removing any tree.** There is no fee for this permit. ## RECREATION

### **PARKS**

There are two public parks within Village boundaries. One is maintained by the Village and is located along the bike path which is located on the vacated portion of Country Club Road between Wiltshire Lane and Huntley Road. The other is Brighton Oaks Park located on Ballard Road which features a tot lot, tennis court, and basketball courts. This park is maintained by the Crystal Lake Park District.

Additionally, the Village owns the Kishwaukee Fen, which is a designated State of Illinois Nature Preserve, located west of Lakewood Road adjacent to Hole 3 of the RedTail Golf Club.

All Village residents are part of the Crystal Lake Park District and thus are able to use its parks, facilities and programs at resident rates. The Park District mails all residents a quarterly brochure of its programs. For questions, call the Crystal Lake Park District at 815/459-0680.

Village residents living between the west side of Riverside Drive and the east side of Huntley Road are eligible to join the Country Club Additions Property Owners Association (CCAPOA), which operates and maintains four private parks along the south shore of Crystal Lake for the use of its members only.

### **BEACHES**

The Crystal Lake Park District has two public beaches on Crystal Lake, which all Village residents can use for a nominal fee. Both have lifeguards and picnic areas. One of these beaches, West Beach, lies within Lakewood's boundaries. Additionally, two homeowners' associations operate private beaches on Crystal Lake for the use of their members only: CCAPOA has four private beaches, and the Lakewood Manor Association has one private beach.

### **BOATING**

All residents of the Crystal Lake Park District are eligible to boat on Crystal Lake. The Village and the City of Crystal Lake have a joint agreement for regulating and patrolling the lake. Canoes, rowboats, paddle boats, and small sailboats can be rented at Main Beach. Residents owning their own boat, which is registered to a Village address, can launch them on Crystal Lake as long as they purchase an annual boat decal at the Crystal Lake Park District Building. A current boat registration or proof of application for a current registration or proof of purchase for non-powered devices, plus a driver's license are required to purchase the decal. The Park District also sells keys to Park District residents for its two launches at Main Beach and West Beach. CCAPOA sells keys to its launch at Beach 7 only to CCAPOA members.

Only non-motorized or battery-powered watercraft is allowed on the Turnberry lakes. Available only to residents within the Turnberry Lakes Special Service Area 8.
